

- 1. Subject to the provisions below, Hickman Edge Systems, LLC. ("Hickman"):
 - a. Warrants that its products with Post-Coated Fluoropolymer, Kynar 500®/Hylar 5000® finish (the "Products") are warranted against manufacturing defects for a period of **30** years from the date of shipment.
 - b. Warrants that the Products will not chalk, fade, blister, flake, crack, peel, rupture or perforate for a period of 30 years from the date of shipment.
 - c. Warrants that the Products will not change color more than 5 E units or chalk in excess of ASTM 04214 07 rating of 8 during the 30-year period starting on the date of shipment.

For purposes of this limited warranty, the term "free from defects in material and workmanship" does not include waviness present in the flat area of the Products, due to inconsistency in the alloys, galvanizing process, light gauge metals, uneven substrates, installation and/or misalignment of support systems over which the Products are applied, which the industry has accepted as being prevalent and normal. Such waviness shall not be the cause for a claim under this or any other warranty.

- 2. You must notify Hickman in writing about any warranty claim within 30 days after you notice a problem. If, after receiving prompt written notice, Hickman determines that the Products are not as warranted, Hickman will either:
 - a. Refinish the failed Product
 - b. Replace the failed Product

Decisions as to refinishing or replacing will be made solely by Hickman. In all cases, Hickman reserves the right to approve and negotiate the contract for such refinishing or replacing. Refinishing of the Product shall be performed by using standard finishing practices and materials, not necessarily replacing the product, at Hickman's discretion. The remedy under this limited warranty is available only for those Products actually exhibiting a manufacturing defect as set forth above. Any refinished or replaced Product will be warranted only for the remainder of the original warranty period. Hickman's liability under the terms of this limited warranty will be limited to the direct cost of refinishing or replacing the failed Product. Hickman's maximum aggregate liability arising out of or related to this limited warranty shall in no event exceed the original purchase price of the Product.





- 3. This limited warranty does not apply where the Products have:
 - a. Been subjected to abuse, misuse, neglect, negligence, accident, improper testing, improper installation (which term includes failure to permit drainage of standing water), improper storage, improper handling, abnormal physical stress (including defects resulting from Products being formed beyond the limits of the surface coating elasticity), abnormal environmental conditions (including corrosive or aggressive atmospheric conditions such as chemical fumes or direct salt spray), failure to remove protective masking, metal dust and shavings, or any use contrary to any instructions issued by Hickman.
 - b. Been reconstructed, repaired or altered by persons other than Hickman or its authorized representative.
 - c. Been used with any third-party product, hardware or product that has not been previously approved in writing by Hickman.
 - d. Been damage by other trades or materials substituted for, or used in addition to, the Products. This limited warranty only covers the Products and does not cover any other material obtained from other sources.
- 4. THIS LIMITED WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS AND GUARANTEES, WHETHER EXPRESS OR IMPLIED, WHETHER BY STATUTE, AT LAW OR IN EQUITY, INCLUDING THE IMPLIED WARRANIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THIS LIMITED WARRANTY IS YOUR EXCLUSIVE WARRANTY FROM HICKMAN AND REPRESENTS THE SOLE REMEDY AVAILABLE TO ANY OWNER OF THE PRODUCTS. HICKMAN MAKES NO OTHER REPRESENTATIONS, CONDITIONS, GUARANTEES OR WARRANTIES OF ANY KIND OTHER THAT STATED HEREIN. HICKMAN WILL NOT BE LIABILE IN ANY EVENT FOR CONSEQUENTIAL, PUNITIVE, SPECIAL, INCIDENTAL, OR OTHER SIMILAR DAMAGES OF ANY KIND, INCLUDING DAMAGE TO THE INTERIOR OR EXTERIOR OF ANY BUILDING, WHETHER ANY CLAIM AGAINST IT IS BASED UPON BREACH OF THIS WARRANTY, NEGLIGENCE, STRICT LIABILITY IN TORT, OR FOR ANY OTHER CAUSE. SOME JURISDICTIONS DO NOT ALLOW LIMITATIONS ON OR THE EXCLUSION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.
- 5. This limited warranty may not be changed or modified except in writing, signed by an officer of Hickman. No one (other than officer of Hickman) has the authority to assume any additional or other liability or responsibility for Hickman in connection with the Products except as described in this limited warranty.
